### General Purpose of job:

To provide the highest-level customer experience through the processing of import and air export shipments in support of CRAF Team.

### Essential Duties and Responsibilities:

- o Prioritize, schedule, and route shipments for import and air export transportation.
- Complete day-to-day coordination, execution and tracking of import and air export shipments.
  - o Ensure all NRA information is entered into each shipment.
  - Prepare ISF Filings
  - o Complete EEI Filings as required with 100% accuracy.
  - Schedule and arrange pickups.
  - o Book space with air carriers.
  - Coordinate documentation between customers, vendors, forwarders, and brokers.
  - Obtain arrival notices from steamship / co-loaders.
  - Prepare quotations for and liaise with overseas offices and partners.
    - o Track and trace freight, as well as provide estimated times of arrival and verify piece counts.
    - o Gather proof of deliveries and enter them into the operating system.
    - Request and enter vendor costs into each shipment, prepare to invoice within time frame of ICAT policy.
    - o Keep the information in the TMS (operating platform) updated and accurate.
      - Including tracking notes, service issues and vendor issues
  - Prepare documents for cancellation requests or other refunds on payment platforms, such as for pay cargo, cargo sprint etc.
  - Request and enter vendor costs into each shipment, prepare to invoice within time frame of ICAT policy.
  - Keep the information in the TMS (operating platform) updated and accurate.
    - Including tracking notes, service issues and vendor issues
- Maintain pace with the DoD GFM and Spot Bidding market by providing the most cost efficient, profitable, and competitive rates to gain awards.
- o Make business decisions regarding choice of vendor, invoice amount and profit margin.
- o Provide innovative solutions to customer service issues/barriers.

  - o Minimum of 1 year in CHB entry-writing experience
  - o Complete understanding of the Harmonized Tariff System
  - Complete understanding of customs power of attorney
